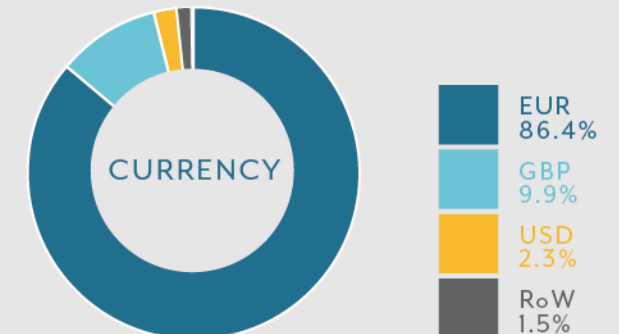
Q2-2019 Revenue Overview



HY-2019 Revenue Overview

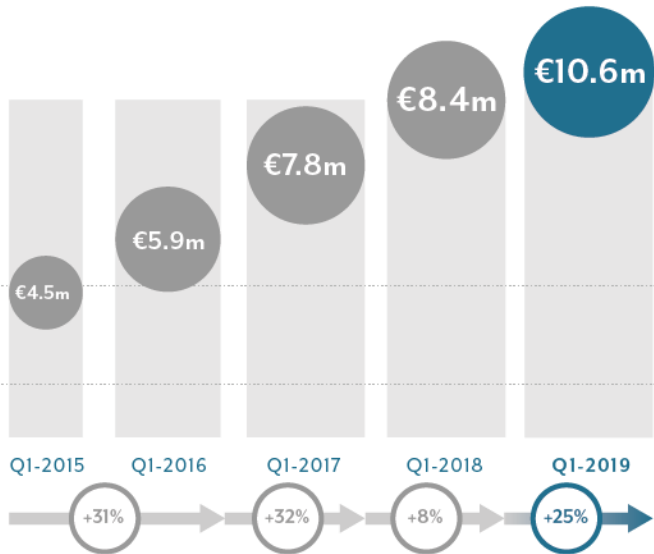

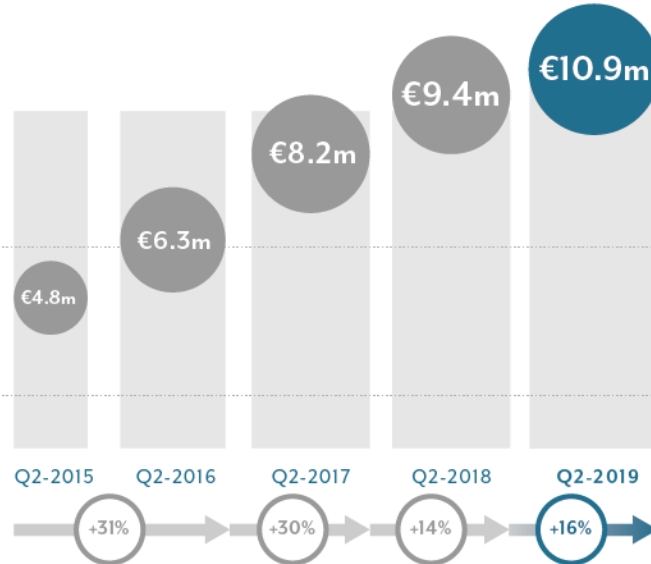


BPO Revenue Trend

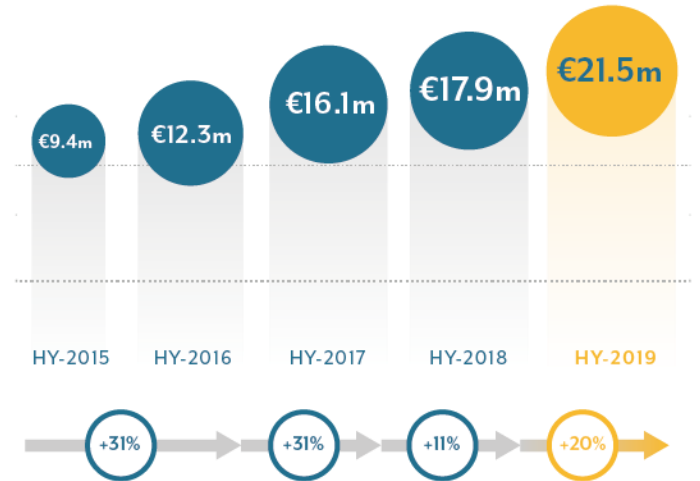
